



TERMS AND CONDITIONS

“Xin chào Hà Nội: Cross-border Growth with E-commerce and Digital Solutions” PRORGAMME

These Terms and Conditions takes effective from August 16th 2024

Participant is advised to note that when Participant participates in the Prorgamme and/or agrees to receive any promotional benefits offered by the Prorgamme, it is deemed that Participant has read, understood, and accepted these Terms and Conditions (“**Terms and Conditions**”).

1. **Prorgamme:** “Xin chào Hà Nội: Cross-border Growth with E-commerce and Digital Solutions” (the “**Programme**”).

- 5.2. Check-in and receiving participant keychain are applicable for all participants who received Email Confirmation from Bank.
- 5.3. Experiencing activities and receiving other Gifts/ Promotions at the display area of participating partners in the Programme are not under the jurisdiction of the Bank. In case, there is a problem or complaint related to the filming activities presented by the partner in the Program, the Participant is kindly requested to contact the relevant partner for resolution.
