

PROGRAM TERMS AND CONDITIONS

The Customer should note that when the Customer participates in the Program or agrees to receive incentives under the Program, the Customer will be deemed to have read, understood and accepted these Terms and Conditions ("Terms and Conditions").

6. Gift receiving process and announcement timeline from UOBV:

- UOBV will contact and notify Customers who are eligible with the promotion via contact information customers register with UOBV

- The Bank may contact the Customer via the phone number/email registered with the Bank to verify some information and request additional documents if necessary. The Customer agrees that the Bank can use the Customer's image and information for advertising and promotional purposes during and after the Program ends without having to ask any further advice from the Customer.
- The Bank is not responsible for the failure to send the notice via the Customer's phone number
 or email address registered with the Bank, when the Customer fails to provide and update
 correct information, or the e-mail is sent to the spam box (Spam / Junk); and when the
 Customer's telecommunications service provider blocks notifications from the Bank for any
 reason.
- When the Bank deems it necessary, the Bank shall have the right to change the Gift with another promotional product of equivalent value, but not exceeding the above Gift value in any case.
- For disputes arising related to the Program, the Bank will resolve in the spirit of cooperation with the Customer. In case the parties fail to reach an agreement, the dispute will be resolved in accordance with Vietnamese law.
- The Terms and Conditions governing the Bank's current account shall be applied concurrently with the Terms and Conditions of this Program.
- The Bank reserves the right to amend the Terms and Conditions of the Program from time to time. Changes (if any) will be notified or registered in accordance with the law before the date of application.
- The Terms and Conditions of this Program are made in English and Vietnamese. In the event of a conflict between the English and Vietnamese versions of the Program Terms and Conditions, the Vietnamese version shall prevail to the extent of such inconsistency.
